Visitor Parking – The Board continues to receive complaints about unit owners parking in visitor parking. Remember – each unit has a garage and one outdoor parking space. Those should be utilized for unit owners and guests before visitor parking is used.

Visitor parking is for NO MORE than 3 consecutive days – if a unit owner is expecting a guest for longer than 3 days, they must obtain a visitor parking pass.

Board meetings are held via zoom. If a unit owner wishes to attend, they must notify the management company prior, and a link will be provided. All board meetings are located on the website. Please keep in mind that Board meetings do get canceled on occasion.
